

GOVERNANCE & ORGANIZATION

Hollywood operates under a Commission-Manager form of government with an elected Mayor serving at-large and six City Commissioners elected by district. The City is a full-service municipality with approximately 30 departments and divisions delivering comprehensive services to residents and businesses. Appointed positions include the City Manager, City Attorney, and CRA Executive Director. The City employs approximately 1,414 full-time employees, 223 part-time employees and operates with an annual budget exceeding \$950 million.



ABOUT THE JOB

The City Attorney's Office serves as the primary provider of legal counsel to the City Commission, City Manager, City departments, advisory boards, and the Community Redevelopment Agency. The Office is responsible for legal interpretation, ordinance and contract drafting, and representation of the City in legal proceedings.

Reporting to the City Attorney, the Senior Assistant City Attorney will:

- Research and draft legal opinions for City leadership and departments
- Draft ordinances, resolutions, and transactional documents
- Provide legal advice on land use, housing, utilities, construction, and procurement
- Advise boards, including the Planning and Development Board
- Assist in supervising and coordinating work assignments within the Office
