## ABOUT THE JOB

Working under the direction of the City Manager, the Public Works Director serves on the City's senior leadership team, with primary responsibility for the operation, administration, and overall performance of the Public Works Department. The Director must exercise considerable autonomy, independent judgment, and technical expertise in managing all aspects of the Department including Water, Wastewater Collections, Reclaimed Water, Solid Waste, Stormwater, Streets, and Fleet Maintenance.

A summary of the position's duties and responsibilities include:

- Ensures that the City's infrastructure is maintained through appropriate planning and evaluation of City resources and facilities; develops long-term staffing and facility plans to support projected service needs.
- Plans and directs all Public Works Department operations, facilities, and personnel in water and sewer utilities, stormwater, streets, and fleet maintenance.
- Coordinate with stakeholders including residents, developers, City leadership, and external agencies.
- Lead emergency response planning and coordination for natural and manmade events.
- Addresses complex resident inquiries regarding public works services and issues.

## KEY PROJECTS FOR 2026-2027

- Avalon Park Development: The 2,500-acre mixed-use development within Ormond Beach's service territory and proposed to be annexed into the City with ~10,000 residents in single-family homes, townhouses, and apartments. At build out, the development will significantly increase water/sewer demand with related utility system improvements
- I-95 & US-1 Interchange Improvements in coordination with FDOT to ensure City input into the design and aesthetics of the new interchange reflects desired community design elements and related utility issues
- Public Works Facility modernization and upgrades
